### 2013 Election of Board Members

#### DECLARATION OF RESULT

I declare the results for the Ngā Hapū o Ngāruahine Iwi Inc election of Board Members that closed on Tuesday 9<sup>th</sup> April 2013.

I confirm that the official result was determined after the scrutiny of the electoral roll was completed, the validity of all votes was determined, and all valid votes were then counted.

I therefore declare **Bonita BIGHAM** to be elected as the Board Member for the **Ngāti Tu** hapū electorate.

I therefore declare **Christine (Ngawai) HENARE** to be elected as the Board Member for the **Ngāti Haa** hap electorate.

The voter return was 35.00%, being 624 votes of which 36.22% voted via the internet and 63.78% voted by post.

In addition to the above election results, I also confirm the successful candidates for the following positions where no elections were required in 2013:

**Kanihi-Umutahi Hapū Electorate** (1 ordinary and 1 extraordinary vacancy)

As only one official nomination was processed for each position in this hap electorate, **Omahuru ROBINSON** (term ending March 2014) and **Tihi Anne Daisy NOBLE** (term ending March 2016) are declared elected unopposed as the Board Members for the **Kanihi-Umutahi** hap electorate.

**Ngāti Tamahuroa me Titahi** (1 vacancy)

As only one official nomination was processed for this hap electorate, **Te Pahunga Martin DAVIS** is declared elected unopposed as the Board Member for the **Ngāti Tamahuroa me Titahi** hap electorate.
